2024 TOP LEGISLATIVE PRIORITIES

The Environment Council of Rhode Island is a coalition of more than 60 Rhode Island organizations that advocate for policies to protect and enhance the environment. Our policy priorities address some of Rhode Island's most pressing environmental issues.

S-2952 / H-7617: Building Decarbonization Act

S-2952 / H-7617: Building Decarbonization Act (Kallman / Kislak): Rhode Island's building sector (including residential, commercial, and industrial) produces almost as much greenhouse gas emissions as the largest sector – transportation. However, our efforts to reduce building emissions are far behind the progress underway for the transportation and electricity sectors. This bill begins to address emissions from both existing buildings and new construction, with two main sections.

Section 1 creates a benchmarking program for large buildings. It records usage of fuel, water, and GHG emissions over a three-year period. The data collected will enable the Office of Energy Resources to develop a Building Performance Standard for **large buildings to reduce their emissions per the Act on Climate**.

Section 2 addresses emissions from new construction by providing stepwise **tiers, by which new buildings must become all-electric to meet the Act on Climate**. New building permits will initially specify that buildings must be "electric-ready", followed by requirements for public buildings to be built all-electric, while also giving municipalities the authority to require all-electric construction on a faster timeline. The bill includes provisions for public projects to utilize apprenticeships and labor standards and for affordable housing and electricity. Making our new buildings all-electric now avoids stranded assets of gas appliances and pipes.

S-2535 / H-8127: Environmental Justice Act (Euer / Alzate): This bill requires the Department of Environmental Management to designate specific geographic areas of the state as **Environmental Justice (EJ) Areas**, based on factors including low-income levels, percentage of minority population, and/or lack of English language proficiency. Designation of an EJ area may also be initiated by petition by area residents. Under this bill, approval of certain permit applications must include assessment of their environmental impact, **including cumulative impacts** within the specified area (a new consideration specified by this bill). Additionally, all such permits will require a public hearing that provides for **the fair treatment and meaningful involvement of those who live in the area**.

Previous versions of this bill have passed the Senate in each of the last three years but have not passed the House of Representatives. The sponsors continue to work with the House to achieve passage of this year's bill.

ECRI's 2024 TOP PRIORITIES – CONTINUED

H-7774: Appropriation of \$78 Million to RI Public Transit Authority (Alzate): Transportation is the largest source of GHG emissions in the state of Rhode Island, making up almost 40% of the state's emissions. To reduce emissions from the transportation sector, we must not only electrify all vehicles on the road but reduce vehicle miles traveled (VMT) by decreasing the number of single-occupancy vehicle trips. Expanding public transportation is an important way to do just that. **Rhode Island's Transit Master Plan ("Transit Forward RI") shows the way**, but since its adoption in December 2020, it has never been funded.

In fact, **RIPTA has been underfunded for years**. Rhode Island does not spend nearly as much on public transportation (\$19 per capita per year) as its neighboring states (\$68 in CT , \$239 in MA). Furthermore, RIPTA does not have enough drivers due to low salaries.

The Governor's proposed 2025 budget is **\$8 million below RIPTA's current need**. An additional **\$24 million is required to hire, train, and pay drivers a livable wage**. An annual supplement of **\$46 million will also be needed to start meaningful state-wide funding of Transit Forward RI**. The \$78 million total requested by Rep. Alzate's H -7774 is about 0.6% of the enacted 2024 budget, and about 9% of its total transportation funding. According to Grow Smart RI, 77% of Rhode Islanders live within a 10-minute walk of public transportation. We need more frequent buses and more efficient bus routes. Now is the time to develop real public transit in Rhode Island – for the environment, for public health, and to attract enough riders to make a difference.
