I. Welcome and Introductions (all)

- Participants introduce themselves on zoom

II. President's Report

- Priscilla goes over recent ECRI successes – transitioning to online meeting, releasing an op-ed in ecoRI news, contributing to the effort to successfully get the governor to acknowledge
- Priscilla discusses \$10K award from National Wildlife Federation, to be used for strategic planning and as a matching grant
- Laura from the nominations committee gives a report – aiming to elect officers next year. Committed roles for next year are: Priscilla as President, Sue and Mal will continue as VP Communications, Eugenia Marks will continue, Greg will continue as NWF delegate. ECRI is seeking a new Treasurer, Secretary, VP Development, and 2 more people from the nominating committee.

III. Approval of March Minutes (Due to the Pandemic, April's meeting was cancelled)

- Paul Beaudette moves to accept the minutes, Jerry Elmer will second the motion. No abstentions or oppositions. Minutes are approved.

IV. Presentation about Green Justice Zones (Court King)

- 1790 – Samuel Slater and Moses Brown opened first cotton spinning factory. Providence and RI were a hub for a slave trade. Context for injustices today.
- Industrialization and pollution that comes with it creating negative environmental impacts.
- Sea level rise will dramatically impact providence.
- Court's role is to help with community implementation of the City of Providence's Climate Justice Plan.
- Shows slide of select Climate Action Milestones for RI.
- The Climate Justice Plan was crafted in partnership with the Office of Sustainability's Racial and Environmental Justice Committee and with Providence residents most impacted by environmental harm. The city of Providence is working to reach back out to communities at the frontline of climate change impacts – that's the centering of Green Justice Zones (these zones are an idea that came out of Minneapolis).
- Negative environmental impacts that harm communities living in these zones include high levels of asthma, high levels of lead in blood, and other key indicators.
- Read the climate justice plan and listen to "Future Stories" – what would Providence be like if communities had what they needed to thrive?
- There are important roles for frontline community members and for allies to amplify the work that's being done.
