2023 LEGISLATIVE PRIORITIES

Environment Council of Rhode Island (ECRI)

The Environment Council of Rhode Island (ECRI) is a coalition of more than 60 Rhode Island organizations that advocate for policies to protect and enhance the environment. Our policy priorities would address some of Rhode Island's most pressing environmental issues.

May 19, 2023

Beverage Bottle Recycling Act (\$753/H5502) Senator Valverde and Representative McEntee

Establishes a container deposit system— a 10¢ refundable deposit. Empty beverage bottles are scattered throughout Rhode Island. Our current recycling program fails to collect them, and tons of bottles are buried in our landfill every year. This bill is carefully crafted to succeed with redemption, recycling and reuse. (HFFS 4.26 / 3.23)

"Solar Siting Reform" Net Metering (S684/H5853) Senator DiMario and Representative Speakman

Shifts state-level incentives for solar outside of core forests— defining them in state law as unfragmented forest blocks of single or multiple parcels 250 acres or greater. This collaborative bill seeks to balance RI's need for protecting our forests and developing solar. It discontinues incentives for solar development in core forests and expands incentives for solar energy development outside core forests and with caps. It also promotes strong labor standards. (HFFS 3.29 / 4.5)

ENVIRONMENTAL JUSTICE:

Environmental Justice Act (S770/H6196) Senator Euer and Representative Alzate (S:passed / H: HFFS 4.5)

Creates a definition of Environmental Justice Areas, requires RI DEM to create a list of Environmental Justice Areas. It establishes requirements to be met by any applicant seeking a permit for developments with environmental or cumulative impacts within a specified Environmental Justice Area.

Green Justice Zones (S909/6357) Senator Mack and Representative Morales (Neither heard by 5.19)

Establishes a first-in-state Green Justice Zone specifying locally determined rehabilitation of environmental and public health impacts. Future projects that threaten air or water pollution, including cumulative impacts, will require community approval. A Green Justice Zone board will oversee and manage the work required to remediate the zone.

BUILDING ENERGY EMISSIONS:

Building Performance Standards (S166/H5425) Senator Gu and Representative Kislak (166: 0 /5425:HFFS)

Requires tracking energy use and greenhouse gas emissions from residential and commercial buildings, gradually extending to smaller ones. After collecting data, standards would be set for progressively reduced emissions.

Building Code Updates (\$855/H6101) Senator Gu and Representative Edwards

Requires the RI Building Code Standards Committee to adopt updated provisions of the International Energy Conservation Code with 100% required compliance, including electric readiness. (Both HFFS)

CALIFORNIA VEHICLE EMISSIONS STANDARDS (\$195/H6055) Senator DiMario and Representative Cortvriend

Requires that the RI DEM adopt motor vehicle emission standards based on those of California which requires that motor vehicle manufacturers steadily increase their percentage of electric vehicles to 100% by 2035. A similar program specifies progressive electrification of newly built trucks. (195:postponed / 6055: HFFS)

FARMLAND PRESERVATION FUNDS (S560/H6018) Senator DiPalma and Representative McGaw

Allots \$5 million to the RI DEM for preservation, protection, and conservation of farmlands in Rhode Island, enabling critical matches for federal funding for the preservation of farmland for local food production. (0/6018 HFFS 5.17)
